When we discussed the current actions in place within our LCAP and ELO plans with stakeholders it was expressed unanimously to continue the actions into the 2022-23 as well as the 2023-24 school years to continue to provide services and support to students and staff.

LEA Representation- Administration, Students, Certificated Teachers, Maintenance and Operations, Special Education Department, Nutritional Services, additional classified employees.

Maintenance and Operations- Maintaining ventilation systems with MERV 13 filters will ensure our classrooms are safe environments for students and staff. Additional cleaning supplies are essential to improve the efficiency and proper cleaning and sanitization of common use areas.

Administration- Our ELO and LCAP provide services for the students of East Nicolaus directly supporting their social and emotional health as well as addressing the needs academically in regards to learning loss and continuing efforts to provide digital access to every student with a device and connectivity through a uniform academic platform (Apex). This past school year ENHS admin worked with staff on analysis of data by utilizing Apex and Google classroom data. ENHS has continued to identify and monitor students who need intervention classes and support. Independent study regulations brought about by legislation AB130 requires additional support to Independent Study students. The district will address this by providing and Independent Study Coordinator to support and service the students with the Apex Academic platform.

Students- Students have voiced their concerns over a decrease in student participation in activities and a growing concern of negative behaviors on our campus. Concerns regarding a changing in our school culture and climate are causing some students to be anxious. Some students have voiced concerns over a safe environment to attend class and wish to be placed in Long Term Independent study until the pandemic is over. Students also concerned about credits or poor grades from the previous year and how that may impact their future.

SPED-Providing for social and emotional support through promotion and awards to recognize Sped students through the Covid-19 pandemic. ENHS will provide additional support to the SPED department by improving technological services, providing new technological devices to ensure that each student has access remotely if needed during the Covid-19 pandemic. Community Representatives- Fit and Family Support, Booster clubs and Foundation meetings. These stakeholder groups identify

the challenges students are facing associated with returning to school including increased behavior issues and anxiety. It has been suggested that we continue with school counseling services and increase the use of the Sutter County Office of Education counseling services as needed.

Teachers- Through staff meetings input was gathered to address the needs of staff to help support students academically through distance learning and Independent Study due to Covid-19. Additional technology upgrades are needed to ensure Google Classroom and Zoom sessions are available for students anytime they may be under a quarantine or extended absence period. The district also needs to provide additional devices to students and provide remote connectivity to provide access.

Professional development opportunities were provided to staff on an ongoing basis as we moved to hybrid and distance learning formats. Continue to provide professional development in ELA/ELD, Math, History/Social Science, Science, and other technical subjects. Continue to provide services for English learners which increase English proficiency and support reclassification Continue to provide relevant professional development for serving the diverse needs of English learners Re-evaluate the Reclassification policy as needed.

Nutritional Services- Nutrition costs are supplemented. The state and federal government have given wide latitude for meals for ALL students over the course of the past year. With an increase in meals being served to all students there is an increase need for onsite storage to meet the demands. Availability and consistent supply of food items to serve the student population is a growing concern and needs to be addressed through increased storage and supplies.
